# Lower Lake County Waterworks District No. 1 Minutes of the December 16th, 2021 Regular Meeting

### A. CALL TO ORDER

Chair Frank Haas called the Regular Meeting of the Board of Directors to order at 4:00 P.M., Chair Frank Haas, Vice Chair Martin Schleif, Director Frank McElwain, and Director Coleta Barnhart were present. - 1. - 4. **Emergency Intertie-** We are working with DWR to try to get this moved over into Konocti Water's "Cache Creek project", which is an emergency grant fund.
- Labor Board Hearing (Lori)- We had the hearing with the labor board on Lori's case about back pay. It
  went well and seems like it may go in favor of the District. Vice Chair Shleif moved to accept the General
  Manager's report. The motion was seconded by Chair Haas with 4 ayes, 0 nays.
