A. CALL TO ORDER

Vice Chair Cook called the Regular Meeting of the Board of Directors to order at 4:23 P.M.. Vice Chair Brianna Cook and Directors Frank McElwain and Noel Negrete were present. - F. GENERAL MANAGER REPORT:
- 1. DWR Grant Update- James explained that we received a grant of \$500,000 from DWR along with the Intertie funding. This \$500,00 is to go towards a new well at the property we purchased across from well #1. We submitted the draft funding agreement and are waiting for approval. The amount awarded is currently \$500,000 that will go towards a new well and any upgrade tied to the new well. We are requesting any additional \$200,000 for the project to go towards more upgrades with the new well.
- 2. SRF Grant- We put in a request to the State to send an SRF Specialist and help us resubmit a grant application to address our aging infrastructure throughout the District. We should get started within the next two weeks.
- 3. Nissan Work Truck: The totaled truck was picked up today and the insurance payout should be received this week. The General Managers Report was accepted on a motion by Director Negrete, seconded by Director McElwain, with 4 ayes, 0 nays.

1. Consideration to Approve General Manager Employment Agreement and Authorize Board Vice Chairman to Sign: The agreement was reviewed by the Board. A motion was made by Director McElwain to accept the General Manager Employment Agreement for James Kingland. This motion was seconded by Director Negrete and passed with 4 ayes, 0 nays.
