### A. CALL TO ORDER

Chair Fabela called the Regular Meeting of the Board of Directors to order at 3:32 P.M. Directors Monique Fabela, Frank McElwain, and Charles Farrell were present. Amy Loren, Clerk of the Board was also in attendance, as well as manager James Kingland, and staff members Mike Kallerman, Summer Dahlquist, and Wayne Rivera. No public was present.

B. APPROVE MINUTES OF THE BOARD OF DIRECTORS REGULAR MEETING HELD JANUARY 23, 2024: On a motion from Director McElwain, seconded by Director Farrell, the minutes were approved with 3 ayes, 0 nays.

GM Report: James reported that the ground is saturated, and wells are full. We had two unfortunate incidents of hydrants getting hit in traffic collisions the past month. The first hydrant has been replaced and we are pursuing an insurance claim. The second hydrant will be replaced soon. The office roof was leaking after the last storm. The high winds we experienced seemed to have blown the flashing back around a vent. We'll see after the next storm if the leak is fixed. James also updated that we no longer supply water to Cache Creek Mobile Home Park as they were red tagged due to PG&E removing their generators.

Office Report: Amy updated the Board that we have finally begun landscaping the front of the office. Ornamental boulders are in place and the tree has been ordered. The General Managers Report and Office Report were accepted on a motion by Chair Fabela, seconded by Director McElwain, with 3 ayes, 0 nays.
